In fiscal year 2016 over \$568,158 was given by 1,257 supporters. The highest dollar volume was designated for our endowment. 150 gifts were provided by 47 supporters to advance a JRMCC priority goal of sustainability and independence. Gifts numbering 960 from 257 supporters provided \$124,200 to JRMCC Oncology Project. Phase I of our Journey to Oncology Campaign was completed in FY 2015. During FY 2016 we started Phase II fundraising efforts to provide oncology treatment to the estimated 252 patients in our service area annually. 529 supporters contributed 1,713 gifts totaling \$129,773 toward the Greater JRMCC Fund. Monies from this fund benefit the area of greatest need as determined by the JRMCC Foundation Board of Directors.
