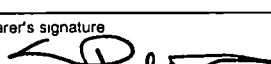

CLIENTS ARE OFFERED TRAININGS IN LIFE AND JOB SKILLS, FINANCIAL MANAGEMENT, NUTRITION, AND PARENTING. CASE MANAGERS IDENTIFY RESIDENTS' JOB READINESS SKILLS AND WORK TO FILL GAPS OR BARRIERS. CHILDCARE IS ARRANGED WHILE WOMEN
