Improved Foundation Infrastructure. In September 2015 PFund Foundation launched its brand new website www.PFundFoundation.org. This more accessible website contains updated content and was built on a content management system so that updates can be made in real time at low to no cost. In addition, PFund Foundation began using ZoomGrants to administer an online application for our grant-making. This improvement has reduced printing and mailing costs, provided improved review tools for our volunteer community reviewers and made the process far more efficient and acceptable for those applying. In the fall of 2015, PFund Foundation moved into the Center for Progressive Philanthropy (2801 21st Ave S, Ste 132B, Minneapolis, MN 55407). The center contains two conference rooms which has allowed us to host more events and meetings than we could at our office in Long Park. The location is accessible by MetroTransit lines including the 21 bus and Blue Line train. The suite also houses Headwaters Foundation for Justice, Native Americans in Philanthropy and Tiwahe Foundation. We're happy to be sharing space with industry colleagues and are grateful that our administrative and contract costs have now been made much more streamlined. Elevated Priorities. We asked an important question: what's next? Although the Supreme Court ruled in favor of marriage equality in June of 2015, the fight for LGBTQ rights and fair treatment is far from over. We recognize that the landscape of the LGBTQ movement has shifted. Barriers and mistreatment based on race, class, gender identity and sexual orientation call for our community to respond. PFund Foundation is ready to provide the resources and opportunities to address these disparities. Consequently, we developed three elevated priorities to help focus our attention and work: queer People of Color, Transgender and Gender Non-Conforming people and LGBTQ North Dakotans and South Dakotans. Why these criteria? 1) LGBTQ people of color are six times more likely to experience poverty than LGBTQ white people. Disparities in education, housing and employment are vast. 2) Anti-transgender bias and policies continue to reinforce negative stereotypes and treatment. Consequently, transgender people are 4 times more likely to live in extreme poverty and are the fastest growing segment of our community experiencing extreme violence because of their gender identity and presentation. 3) North Dakota and South Dakota have the most discriminatory policies against LGBTQ communities in our region. You can be married on Sunday, fired on Monday and evicted on Tuesday simply because of your sexual orientation, gender identity or expression. Policies are hostile and anti-LGBTQ opposition is hyper-vigilant. Investing in Bold LGBTQ Leaders. PFund Foundation invests in bold leaders so that lesbian, gay, bisexual, transgender and queer communities can thrive. We're extremely happy to share that after our grant process, we're living into our Elevated Priorities with the selection of 21 Individual Leaders. This year our program grew from 16 to 21 leaders awarding \$61,200 for their educational and professional development pursuits. -One-half identify as transgender or gender nonconforming. -Two-thirds identify as people of color. -Nine are from across our region. -We intentionally invested in leaders across the lifespan ranging in age from 17 to 61. This year's cohort is a diverse and inspirational group of LGBTQ leaders. These leaders are recognized for their leadership in their communities, from advocating for inclusive school climates and policies to excelling in the performing arts and educating their peers about LGBTQ communities. Funding Forward. PFund Foundation continues to position itself as the expert in queer philanthropy in the upper Midwest. In a post marriage equality reality, funding is shifting and the Midwest is about to be the most underfunded region with relationship to LGBTQ people and issues in the United States. In March 2016, PFund Foundation and Minnesota Council on Foundations (MCF) proudly co-hosted 'Funding Forward' the national annual gathering for LGBTQ grantmakers in Minneapolis, Minnesota. PFund and MCF worked with Funders for LGBTQ Issues for one year, planning and prioritizing important conversations during the conference. The conference was two-and-a-half days of over 160 philanthropists (foundations and individuals) raising up working strategies to effect change for LGBTQ people - to respond to current emergencies, build capacity, and strengthen infrastructure and communities over the long term. It was an honor for PFund Foundation to co-host this conference and an extraordinary opportunity for our communities in the upper Midwest to inform, educate and foster discussion on the issues that impact our region. The goal of bringing the conference to the heart of Minnesota's foundation-rich community was to galvanize local foundations to attend and commit to improving their organization's practices and commitments to serving LGBTQ people. Additionally, as a national conference, this experience allowed us to illustrate the assets and opportunities LGBTQ people are driving in the upper Midwest, bringing attention from national LGBTQ funders to our region. A direct result of the conference has already been increased membership of the Twin Cities LGBTQ Funders Network.
