Bridge provides a broad spectrum of wrap around services and transitional housing for homeless families, moving them from the crnses of homelessness to self-sufficiency in a two-year program. In 2016, Bridge served 127 families, including their 231 children. Among key accomplishments: 78 clients secured full-time employment, 39 clients enrolled in college courses or vocational training, 43 children received tutoring, 44 children received summer camp scholarships, over two-thirds of families completing program bought homes or secured unsubsidized housing.
