The \$50,000 and \$5,000 annual payment amounts are to be adjusted annually in accordance with the CPI index. These benefits are payable to him only for as long as he lives. There are no guaranteed payment amounts and no survivor benefits at his death. In 2015, Steven Nasatir received payments of \$77,769 from the two supplemental non-qualified retirement plans. David S. Rosen. The Jewish Federation has an agreement with David Rosen which provides for annual payments of \$25,000 per year beginning in 2018 and ending in 2028.
