Artistic - Produce, Promote and Perform Ballets During The Joffrey Ballet's 2015-2016 Season, the company presented five programs: a mixed repertory, Millennials (September 2015, 5 performances), Sylvia (10 performances), Robert Joffrey's "The Nutcracker" (22 performances), a mixed repertory, Bold Moves, (10 performances), and, Cinderella (10 performances). Total attendance was 111,734. Additional performances, Chicago Dancing Festival (3 performances) and the Spring Gala (1 performance), attendance 2,298. The 2 student matinees offered "The Nutcracker" at a discounted rate of \$10, approximately 5,000 attended. The Joffrey toured 5 cities, presenting "The Nutcracker", as well as a mixed repertory. Approximately 25,248 people attended 14 performances.

Joffrey Academy. The Academy, is committed to providing a world-class education built on a foundation of classical ballet to students of all ages, levels and backgrounds. With the talents cultivated at the Academy, students can pursue careers as professional dancers at companies throughout the world, higher education opportunities in dance. Through the Academy's programs, students develop a diverse set of skills including artistry, creativity, discipline and confidence, among others. 1,640 students participated in the Joffrey Academy's programs, and 1,977 adult students attended drop-in classes. The Academy and Community Engagement programs provide high-quality, educational training which form future audiences and build the organization's reputation worldwide.

4c (Code) (Expenses \$ 530,818 including grants of \$) (Revenue \$ 190,429)

Community Engagement. The primary goal of the Community Engagement program is to provide students in all grade levels with a highly structured dance experience where they will develop life skills articulated by Illinois State Board of Education's social emotional learning (SEL) standards such as self-discipline, respect, and confidence through the study of various forms of dance. In addition, these programs help build a strong dance foundation by focusing on correct posture, placement, coordination, strength, flexibility and musicality. By providing this service to the youth, we hope to increase the level of awareness of this art form, and instill life skills that last long after programs end. In fiscal 2016, 6,034 students benefited from The Community Engagement programs.
