INPATIENT PROGRAMS. IN FISCAL 2016, ABBHH HAD 5,670 ADMISSIONS WITH AN AVERAGE LENGTH OF STAY OF 8.3 DAYS. ABBHH PROVIDED CARE TO APPROXIMATELY 1,320 ADOLESCENTS, 3,430 ADULTS AND 920 GERIATRIC PATIENTS. ABBHH OFFERS THE COMPLETE CONTINUUM OF BEHAVIORAL HEALTH SERVICES, FROM PREVENTION AND EARLY INTERVENTION TO TREATMENT AND AFTERCARE. WE OFFER INPATIENT AND OUTPATIENT SERVICES, AS WELL AS CLINICAL PSYCHIATRIC RESEARCH. OUR GOAL IS TO HELP INDIVIDUALS OF ALL AGES LEARN WAYS TO MANAGE MENTAL HEALTH AND SUBSTANCE ABUSE PROBLEMS. ABBHH IS ACCREDITED BY THE JOINT COMMISSION AND LICENSED BY THE DIVISION OF ALCOHOL AND SUBSTANCE ABUSE, WHICH MEANS WE MEET THE HIGHEST STANDARDS OF MENTAL HEALTH AND SUBSTANCE ABUSE TREATMENT. Adventist Health System Sunbelt Healthcare Corporation and Ascension Health, the sponsors of Adventist Midwest Health (AMH) and Alexian Brothers Health System (ABHS), respectively, entered into an Affiliation Agreement that established the Joint Operating Company, Alexian Brothers-AHS Midwest Region Health Co., which became operational on February 1, 2015. The purpose of the Joint Operating Company is to provide a financially and operationally integrated organization for the common management and operation of the health care facilities and operations of AMH and ABHS while preserving the Adventist and Catholic identities and mission priorities that define AMH and ABHS, respectively. In April 2015, AMITA Health was announced as the d/b/a for Alexian Brothers-AHS Midwest Region Health Co. The word AMITA is inspired by words from several languages: friendship in Italian, honesty and truth in Hebrew, and spiritual light and boundlessness in Hindi. These words reflect our core values of friendship, truth, and mutual respect for all, as well as our faith-based call to healing. Although the name is new, the values of our two great organizations will continue to be the foundation of who we are and how we care for our communities into the future. The dedication and promise our caregivers show every day to our patients, their families and each other is deeply rooted in the new name - AMITA Health.

The information in the Community Health Needs Analysis is not exhaustive or conclusive, rather an overview of the issues most prominent in a community. There may be discreet but very important issues in a community that are not able to be detected by this instrument. For example, we became aware that some veterans returning from Iraq and Afghanistan are unable to successfully reintegrate into society successfully. One in three returning vets struggle with substance abuse and one in four have sought treatment for Post-Traumatic Stress Disorder (PTSD). More alarming is the fact that there are 22 suicides per day by our veterans. Treatment offered by the government is too often neither timely, nor in many cases individualized and comprehensive enough to meet the complex needs of veterans with chronic issues, in response long-term residential mental health and substance abuse treatment for up to 50 veterans annually will be philanthropically underwritten. This intensive, coordinated treatment will be offered in a new 48-bed residential facility now being rehabbed and will be only the fourth such residential treatment center for anxiety disorders in the nation.
