FOURTH GRADUATIONON MAY 14TH, 2016, THE 63 MEMBERS OF THE CLASS OF 2016 WALKED ACROSS THE STAGE TO BECOME GRADUATES DURING AUW'S FOURTH COMMENCEMENT. THE NEW GRADUATES REPRESENT EIGHT DIFFERENT COUNTRIES, AND MANY LANGUAGES, TRADITIONS, AND CULTURES. SPEAKERS AT THE CEREMONY INCLUDED DR. MARTIN RAMA, CHIEF ECONOMIST FOR THE SOUTH ASIA REGION OF THE WORLD BANK AND DR. DIPU MONI, CHAIR OF THE BOARD OF TRUSTEES OF AUW AND FORMER BANGLADESH FOREIGN MINISTER. DR. MONI SPOKE OF THE NEED FOR EXCELLENCE AND HIGH STANDARDS, SAYING, "AS AUW GRADUATES, YOU HAVE A PARTICULAR OBLIGATION TO BE BEACONS OF EQUALITY AND RIGHTS AND TOLERANCE OF VIEWS, AND TO HELP IN SAFEGUARDING THE VALUES THAT MAKE HUMAN EXISTENCE MEANINGFUL." ZEBANOSHIN, THE CLASS OF 2016 SPEAKER, REMINDED HER PEERS TO MAINTAIN STRONG ETHICS AND CRITICAL THINKING AS THEY MOVE BEYOND THEIR UNDERGRADUATE YEARS. THE CLASS OF 2016 IS OFF TO AN INSPIRING START. STUDENTS' EARLY EMPLOYMENT PLANS INCLUDED A FELLOWSHIP AT THE AGA KHAN UNIVERSITY IN KARACHI, SOLIDARIT'S INTERNATIONAL NEPAL, AND GRADUATE SCHOOL AT ILLINOIS STATE UNIVERSITY. OTHER AUW ALUMNAE HAVE GONE ON TO WORK FOR THE WORLD BANK, CHEVRON, ROOM TO READ, BHUTAN MINISTRY OF HEALTH, AND TEACH FOR NEPAL. FACULTY AND ADMINISTRATIONBY THE CONCLUSION OF THE 2015-2016 ACADEMIC YEAR, AUW HAD APPOINTED A NEW DEAN OF THE FACULTY, PROFESSOR ROSIE BATESON. DR. BATESON'S MOST RECENT ASSIGNMENT WAS ESTABLISHING THE SAMPOERNA UNIVERSITY IN JAKARTA, INDONESIA, WHERE SHE SERVED AS ITS FOUNDING EXECUTIVE VICE-RECTOR, AND SUBSEQUENTLY VICE-RECTOR FOR STRATEGY & UNIVERSITY GOVERNANCE, FOR THE PAST FIVE YEARS. PREVIOUSLY, SHE WAS PRO-VICE-CHANCELLOR AND PROFESSOR OF HIGHER EDUCATION MANAGEMENT OF ABERTAY UNIVERSITY IN THE UNITED KINGDOM, VICE PRESIDENT FOR STUDENT SERVICES OF THE CENTRAL EUROPEAN UNIVERSITY IN BUDAPEST, WHERE SHE ALSO TAUGHT HIGHER EDUCATION MANAGEMENT AT THE DEPARTMENT OF PUBLIC POLICY, SPECIAL ASSISTANT (U.S.-BASED) TO THE PRESIDENT OF THE AMERICAN UNIVERSITY IN BULGARIA, AND DEPUTY DIRECTOR OF THE AMERICAN COLLEGE OF SOFIA. AN ALUMNA OF THE MANAGEMENT AND LEADERSHIP IN EDUCATION PROGRAM OF THE HARVARD GRADUATE SCHOOL OF EDUCATION, ROSIE BATESON OBTAINED HER PHD IN HIGHER EDUCATION MANAGEMENT FROM THE UNIVERSITY OF SOUTHAMPTON IN THE UNITED KINGDOM. IN ADDITION TO HER ROLE AS DEAN OF FACULTY AND ACADEMIC AFFAIRS, DR. ROSIE BATESON WILL SERVE AS ACTING VICE CHANCELLOR OF AUW. AUW'S LEADERSHIP TEAM WILL BE JOINED BY TWO LONG-STANDING MEMBERS OF THE AUW FACULTY WHO WILL SERVE AS ASSOCIATE DEANS. DR. MEHERUN AHMED, ASSOCIATE PROFESSOR OF ECONOMICS, WILL SERVE AS ASSOCIATE DEAN FOR SPECIAL PROGRAMS WITH RESPONSIBILITY FOR PATHWAYS FOR PROMISE, SUMMER SCHOOL AND OTHER IMPORTANT SPECIAL INITIATIVES. DR. AHMED HAS A PHD FROM THE UNIVERSITY OF WASHINGTON AND HAS TAUGHT AT AUW FOR THE LAST SIX YEARS. DR. HERMAN T. SALTON, FORMER CHAIR OF THE POLITICS, PHILOSOPHY, AND ECONOMICS PROGRAM, WILL SERVE AS ASSOCIATE DEAN FOR ACADEMIC AFFAIRS. DR.
