Our array of comprehensive countering domestic violence services include: a 24-hour hotline, 24-hour emergency shelter (Neville House), criminal justice and legal advocacy, victim rights support, adult and youth support groups, and adult (one-on-one) trauma-reduction counseling. Mid Central Community Action, Inc. also provides: Youth violence prevention programs, 40 hour Domestic Violence Training, Domestic Violence 101 Workshops, Domestic Violence Simulation and professional trainings by certified domestic violence advocates. In the period July 1, 2015 to June 30, 2016 we assisted 3,312 hotline callers in accessing services.

Our housing department lines of business include: homeownership promotion and preservation through homebuyer education workshops, pre and post purchase counseling, and down payment assistance programs; multi and single family transitional housing rental units; and the acquisition of foreclosed or scheduled for demolition homes to rehabilitate and sell for single family occupancy. We also provide multi-unit permanent supportive housing services to formerly homeless single adults. Our financial coaching services include: financial fitness workshops, credit building and repair, budgeting and establishing savings plans education, and debt reduction counseling. Mid Central Community Action, Inc. is a collaborative partner in the Next Step Program to provide bundled services with partnering agencies to help individuals and families become financially secure. In the period July 1, 2015 to June 30, 2016, 510 individuals

Our community services include: emergency assistance (must be documented and beyond individual's control), income support assistance (after completing a workshop and financial counseling sessions), utility assistance, and home owner weatherization services, for qualified candidates.
