Each year, following a specific formula, the Pine Rest Foundation awards grants to Pine Rest Christian Mental Health Services to fund various aspects of behavioral health care and counseling programs. An award of \$564,454 was made to provide funds for financial assistance for patients with the inability to pay for services. An additional \$687,323 was made available for education, prevention, and support programs through the Hospital. Funding was provided for the continued development of a Residency Program and to improve Hospital Based Services through bettering new-employee orientation and training. Funding was also provided to support residential programs, medical training and a peer support program. The remaining \$1,529,395 represents the Pine Rest Foundation as the "single-portal" for all donations intended for the Pine Rest Foundation and Pine Rest Christian Mental Health Services "PRCMHS", the related organization.
