The mission of the Delta College Foundation is to change lives by supporting opportunities and innovation at Delta College. This is accomplished by building relationships with donors, directing fundraising efforts, increasing community involvement to foster college readiness and meeting the training and educational needs of area employers

Contributions of cash, equipment and classroom supplies donated to the Foundation for instructional purposes were transferred to Delta College to enhance educational programs and provide additional scholarships and awards that are not supported by endowments. The Foundation also used funds to publish and distribute an informational magazine featuring Delta College success stories, programs and events available to residents in the surrounding communities. These contributions benefitted the entire college community of 15,900 students and staff, and provided valuable information to residents of the Great Lakes Bay Region.

4b (Code:) (Expenses \$ 1,655,969 including grants of \$ 1,655,969) (Revenue \$)

Contributions to the Foundation for endowments were transferred to the College for investment in the College's Endowment Fund. Investment income generated by the Endowment Fund provided approximately 300 scholarships and awards this past year. Investment income also supported numerous College programs and projects. A few of these are the President's Scholar Program, the Possible Dream Program, the Delta College Planetarium and several teaching chairs. These educational programs benefitted the entire Delta College community of approximately 15,900 students, faculty and staff, as well as residents of all ages living in the surrounding communities.

Donations to the Foundation for non-academic assistance were used to provide emergency funding to currently enrolled students to help them complete the classes they had already begun. These students with special financial needs received help with rent, utilities, transportation and groceries. This additional support beyond the classroom benefitted approximately 126 students.
