Providence-Provident Park Hospital is an active supporting member in community events and partners with many organizations to improve community health, such as American Red Cross, American Heart Association, Multiple Sclerosis Society, Manna Meal Soup Kitchen, Crisis Assistance Program, Physicians Who Care, Parish Nursing program, Shalom Providence Project, American Cancer Society. Community service is an important part of our existence. Charity Care Providence-Provident Park Hospital offers a wide variety of health and wellness programs that meet diverse needs, regardless of economic status and physical condition. The uninsured are more likely to seek care in hospital emergency rooms. Providence-Provident Park Hospital had 120,847 emergency department visits in fiscal 2016. Increasingly, patients are experiencing limited abilities to pay for health care services or qualify for state and federally funded programs like Medicaid that cover only a portion of the cost of services provided. Providence-Provident Park Hospital offers various free clinics. For many Michigan residents, finding someone to care for them when they are sick is not as easy as making an appointment. Lack of health insurance, transportation issues and language barriers combine to create challenges. During the fiscal year ending June 30, 2016, Providence-Provident Park Hospital treated adults and children from the community for a total of 151,580 patient days of service. Providence-Provident Park also provided services to 14,311 outpatient surgery patients.</p>
