THE AGENCY ENTERED INTO ITS 19TH YEAR ADMINISTERING THE WISCONSIN WORKS (W-2) PROGRAM WHICH PROVIDES CASH ASSISTANCE TO FAMILIES WHILE PARENTS PREPARE FOR AND LOOK FOR EMPLOYMENT. DURING FISCAL YEAR 2015-2016, UMOS PLACED 2,053 PROGRAM PARTICIPANTS INTO JOBS.
