Campaign for people with intellectual disabilities The MN Knights of Columbus conducts an annual fundraiser where candy, often a Tootsie Roll, is offered to the public and free-will donations are received by the Council. The high visibility of this program as lead to the campaign being referred to as the Tootsie Roll Drive. Each local council participating then designates these contributions to the Special Olympics and other qualified charities. This year \$344,136 were contributed to these charities, including funding the Fall Classic Special Olympics three-day event. This event provides for teams of over 850 athletes and coaches from all over Minnesota to compete in bowling.

4b (Code) (Expenses \$ 58,844 including grants of \$) (Revenue \$)
Christopher Fund receives donations to be invested with the requirement that the earnings are to be used exclusively for religious, charitable, and educational purposes. This year \$43,438 was paid out to donees.

4c (Code) (Expenses \$ 53,591 including grants of \$) (Revenue \$)
Other Program Services Jim Campbell Scholarship Program provides funds to each diocese to help pay for the continuing education of priest and religious organizations. This year \$6,500 of scholarships were given and an education event were sponsored and included in total program expenses of \$16,773.75. Pennies for Seminars provides funds to each diocese to support the education of seminarians to the priesthood. During this fiscal year, \$18,800 of scholarships were given. Other Small Programs Youth \$5,144. Ultrasound \$2,500. Other \$10,373.
