The Displaced Homemaker Grant provides pre-employment and peer counseling services to displaced homemakers who live in south central Minnesota. Services include workshops, individual peer counseling, testing and assessments, advocacy, resources and referrals, and direct client assistance as appropriate. LWPC served 58 newly enrolled and 34 previously enrolled displaced homemakers in this past fiscal year.

United Way and special project funders provide pre-employment and peer counseling services to women in transition who live in south central Minnesota. Services include workshops, individual peer counseling, testing and assessments, advocacy and resources and referrals. Target populations are low income women, abuse survivors, single parents, and women moving off of public assistance to self-sufficiency. This fiscal year, LWPC served 50 newly enrolled and 9 previously enrolled women in transition. This program also served 51 clients through collaborative programming that were not specifically enrolled in this program.

The funds provided to Displaced Homemakers, and Women In Transition fall into what LWPC considers "specific assistance". The allocation and monitoring of those funds comply with the requirements of the various grantors. "Client Transportation" was a reimbursement of mileage for class participants to attend classes @ \$0.30/mile (\$257) for Displaced Homemakers and a \$100 gas card for a Women In Transition client. The "Snacks/Food" was food bought by Staff to provide a lift during group meetings for Displaced Homemakers (\$262) and Women In Transition (\$19). "Books and Materials" were materials and subscriptions purchased by Staff to use during trainings for Displaced Homemakers. The "Script Cards" were gift cards of various denominations given to class participants to help with gas and grocery purchases while attending LWPC Displaced Homemaker classes. The "Client Assistance" distributions were all given to Displaced Homemaker clients. They included \$250 for assistance with rent, \$50 for the purchase of clothes for work, \$339 for car insurance for a vehicle to go to work, \$200 for a damage deposit, and another \$94 for car insurance.
