True Light Christian School served 100 students in grades preschool through 8th grade. There were 175 contact days of school for grades kindergarten through 8th grade held during the school year.

In addition to the academic curriculum for education, True Light provided:

Opportunities for students to minister and serve in the community; Fine Arts February which included extra learning opportunities in a variety of fine arts areas; a dinner theater written, performed and produced by the 7th and 8th grade classes; a spring musical performed by the kindergarten through 6th grade classes; and multiple learning opportunities through various field trip events

True Light also provided after-school learning opportunities through sports - including volleyball, flag football and basketball.

Additional after-school educational programs included science club, knowledge bowl team and speech team activities. A lunch program was provided for students between 2 and 3 days per week with a focus on nutrition through organic foods and local produce such as meat, fresh vegetables and dairy products purchased directly from farmers as much as possible.

True Light Christian School offers a tuition assistance opportunity for all families of students enrolled in grades kindergarten through 8th grade. Tuition assistance is limited to 50% of tuition for all families, except families of True Light teachers with students enrolled at True Light. For the True Light teachers, there is no limit on the tuition assistance they may be granted. Tuition assistance is determined through an application made by families to an independent company. This company analyzes each families' income, expenses, assets and liabilities, and determines the amount of tuition assistance each family qualifies. This company communicates the amount of assistance to True Light. To apply for tuition assistance, the family must have paid the non-refundable registration fee to True Light as well as the application fee to the independent company. In the 2015/2016 school year, assistance was provided for 19 families providing for a total of 33 students.

During the year we provide opportunities for the students and their families to reach out to serve others. In that endeavor, offerings were given to True Light for the benefit of other ministries. In addition, the 7th and 8th grade students put on a dinner theatre each spring to raise money for missions. These funds were paid out to domestic Christian mission organizations.
