THE FOUNDATION ALSO FACILITATES SUPPORT TO ANY AREA OF PUBLIC SCHOOL EDUCATION DESIGNATED BY AN INTERESTED DONOR, SUCH AS THE MILLER MENTORING PROGRAM AND THE ANNUAL HAAKE POETRY PRIZE COMPETITION.
