IT COLLABORATES WITH MAJOR NATIONAL HIGHER EDUCATION ORGANIZATIONS LIKE THE ASSOCIATION OF AMERICAN COLLEGES AND UNIVERSITIES, AND THE COUNCIL ON UNDERGRADUATE RESEARCH.
