In 1994, the Academy moved to a single 4500 square-foot studio housing two disciplines (drawing and painting), the first student body consisted of 16 students taught by three instructors (Daniel Graves and 2 assistants) with one administrative staff (Susan Tintori). It has since expanded to three countries, 40 principal instructors (13 full-time and 27 adjunct), 4 student assistants and 9 administrative staff (4 are part-time), offering instruction and service to 152 full-time students from 35 countries and over 150 continuing education students per year. During its 25-year period, the Academy developed several important year-long programs: Anatomy (required of all first year students) and Ecorch Sculpture, Art History, and Composition, as well as optional part-time courses including evening sculpture class for painters, and Landscape painting conducted during Fall and Spring trimesters. Enrollment for the academic year program rose from 16 students in 1994 to 151 in 2016. Students study on a full time basis only, 36 hours per week, from October through June, preference is given to applicants who intend to stay the full three years, a fourth year of specialization is the norm. Applications for academic year study exceed available spaces 3 to 1. Equally successful is the continuing education programming with enrollment in most courses reaching 100%. The Academy counts 338 graduates of its painting and sculpture programs, of these, 70% are pursuing careers as professional artists. Each year, this number grows by at least twenty new graduates who complete the three-year curriculum and enter the art market. Their work is featured in the Alumni Gallery on the Academy's website, www.florenceacademyofart.com. The academy realized its long term goal in 2015 to purchase a permanent home in Florence. Renovation of the 19th century customs house was completed in October 2016 in time to inaugurate the 2016-2017 academic year. The 35,000 square foot campus provides 100 students enrolled in drawing, painting and sculpture over 30 northerly lit studios, a library, gallery, bookshop, cafe and two apartments for visiting artists. The program directors and principal instructors are graduates of the Academy's three-year program. The assistants are enrolled in their second or third year, they are selected based on talent and communication skills, and receive tuition scholarships. Their presence guarantees a continuum of the Academy's philosophy and artistic language. Most of our instructors work in one of the Academy's studios, students therefore benefit not only from daily direct instruction and critique, but also from watching the artist at work. Financial aid: Work-study in the form of partial or full tuition scholarships to students amounted to \$204,755 in 2015/2016, and was subsidized by regular tuition income (90%), and Board contributions or private donations (10%). Normally reserved for students in their second or third year of study at the Academy, on a few occasions, financial aid may be offered to first year students who display significant talent and a high degree of motivation in their chosen field of study. The Academy's main source of scholarship funding is the named scholarship drive. A sponsor will know the name of the student they are helping, follow his or her career through the quarterly updates from the School. The Academy acquired for its lending library 600 volumes, and its Art History staff collected over 7000 images for the image archive, it also acquired membership in ArtStore, an on-line database of over 500,000 images operated by the Mellon Foundation. This is made available to students via the library computer and on-line through the Florence Academy Blog. Throughout the years the Academy has purchased or received as gifts from students a collection of drawings, paintings and sculpture numbering close to 200 works. These remain on view to students and visitors in the Academy's student gallery located in the each studio location. These works serve not only as examples of exceptional student work to admire but for study. In addition, the Academy owns four 19th century figure drawings, and received in donation from Edward T. Wilson two original drawings by Jon Leon Grome and Charles Bargue.
