ANNUAL FUND GRANT THE FOUNDATION PROVIDES A GENERAL OPERATING GRANT TO THE ORONO SCHOOL DISTRICT EACH YEAR TO SUPPORT A WIDE VARIETY OF K-12 EDUCATIONAL EXPENSES. IN FY 2015-2016, THE ORGANIZATION UNDERWENT A STRATEGIC RE-POSITIONING THAT INCLUDED INVESTMENT IN ADDITIONAL CAPACITY RESOURCES INCLUDING PERSONNEL, ENDOWMENT AND CONTRACTED PROFESSIONAL SERVICES. THESE INVESTMENTS WILL ALLOW THE ORGANIZATION TO EXPONENTIALLY INCREASE ITS GRANT FUNDING IN FUTURE YEARS IN SUPPORT OF ORONO SCHOOLS’ EDUCATIONAL OPPORTUNITIES FOR STUDENTS. WHILE THESE OPERATIONAL INVESTMENTS NECESSITATED A REDUCTION IN THE CURRENT YEAR ANNUAL FUND GRANT AWARD, THEY PUT INTO PLACE THE RESOURCES NEEDED TO ENSURE THE ORGANIZATION’S ABILITY TO SUPPORT ORONO SCHOOLS AND STUDENTS IN A MUCH LARGER AND SIGNIFICANT WAY IN THE YEARS TO COME. OVER THE PAST 15 YEARS, MEMBERS OF THE ORONO COMMUNITY HAVE QUIETLY CONTRIBUTED TO THE ENDOWMENT FUND. THIS YEAR THE STRATEGIC DECISION WAS MADE TO HIGHLIGHT THIS FUND FOR FUNDRAISING INITIATIVES IN HOPES OF SURPASSING A \$1 MILLION DOLLAR BALANCE. IN 2015-2016, \$202,303 WAS RAISED FOR THE ENDOWMENT FUND, AND THE GOAL WAS ACHIEVED. THE ORONO FOUNDATION FOR EDUCATION MAY NOW DRAW A PERCENTAGE OF ENDOWMENT EARNINGS TO PROVIDE SUPPORT TO THE ORONO SCHOOL DISTRICT. SECURING THESE FUNDS WAS IMPORTANT FOR THE FOUNDATION, BUT THERE WAS A RECOGNIZED AND IMMEDIATE TRADEOFF. THIS IS REFLECTED IN THE REDUCTION OF THE ANNUAL GRANT TO THE ORONO SCHOOL DISTRICT. THIS WAS COMMUNICATED TO THE ORONO SCHOOL DISTRICT PRIOR TO THE FOUNDATION’S ANNUAL GRANT AWARD PROCESS. DURING THIS FISCAL YEAR, A MEMORANDUM OF UNDERSTANDING WAS DRAFTED AND APPROVED BETWEEN THE ORONO FOUNDATION FOR EDUCATION AND THE ORONO SCHOOL DISTRICT. THE PURPOSE WAS TO CLEARLY IDENTIFY THE ROLES AND RESPONSIBILITIES OF EACH PARTY AS THEY RELATE TO THE ONGOING FUNDRAISING AND PHILANTHROPY EFFORTS FOR THE ORONO SCHOOL DISTRICT AND COMMUNITY. PARTICULARLY, THIS MOU WILL DEFINE THE PROCESS, VALUES, AND ACTIVITIES OF BOTH PARTIES IN A COMPREHENSIVE, ONGOING FUNDRAISING EFFORT. THE MEMORANDUM IS INTENDED TO MAXIMIZE THE MUTUAL FUNDRAISING CAPACITIES OF THE FOUNDATION AND THE DISTRICT TO REALIZE THE MISSION OF EMPOWERING ALL STUDENTS TO ACHIEVE THEIR HIGHEST POTENTIAL AND ENSURE THE TRADITION OF ACADEMIC EXCELLENCE.
