Anyone in a position to make decisions about spending CRCSDF resources, who stands to benefit from that decision, has a duty to disclose that conflict as soon as it arises (or becomes apparent). Such person should not participate in any decisions regarding such transactions.

Any conflicts of interest will be noted in the minutes of meetings.
