Provided emergency shelter and supportive services for 122 homeless families and 392 individuals. 64% of the families served by New Directions Shelter moved into more permanent housing; 42% increased their household income by 10% or more; 74% of the adults that looked for employment gained employment; and 96% of the families that needed childcare service obtained free or reduced cost childcare.

Provided supportive housing and supportive services for 33 families including 154 individuals. 89% of the families moved into permanent rental housing when they left the program.
