THE BROADLAWNS MEDICAL CENTER FOUNDATION IS COMMITTED TO RAISING BOTH COMMUNITY AWARENESS AND FINANCIAL SUPPORT FOR BROADLAWNS MEDICAL CENTER (BMC) AS THE COMMUNITY HOSPITAL, BMC IS DEDICATED TO SERVING THE MOST VULNERABLE POPULATIONS AND PROVIDING ACCESS TO QUALITY HEALTHCARE TO THE UNDERSERVED AND AT-RISK INDIVIDUALS WITHIN THE COMMUNITY

BROADLAWNS MEDICAL CENTER FOUNDATION SUPPORTS THE MISSION OF THE MEDICAL CENTER BY FUNDRAISING AND DISTRIBUTING FUNDS FOR VARIOUS HOSPITAL PROGRAMS AND EQUIPMENT. FUNDS ARE RAISED THROUGH INDIVIDUAL AND CORPORATE DONATIONS, FOUNDATIONS, GRANTS AND IN-KIND CONTRIBUTIONS. REVENUE COLLECTED HAS BEEN USED TO SUPPORT THE FOLLOWING NEEDS AT BROADLAWNS MEDICAL CENTER: FAMILY BIRTHING CENTER - BROADLAWNS INTENDS TO RENOVATE THE EXISTING FAMILY BIRTHING CENTER TO PROVIDE ENHANCED LABOR, DELIVERY, RECOVERY, AND POSTPARTUM ROOMS THAT ARE LARGER, MORE CONDUCTIVE FOR MEDICAL EQUIPMENT AND MORE ACCOMODATING FOR VISITORS. THE MODERNIZATION OF THE FAMILY BIRTHING CENTER WILL ALLOW FOR GREATER PRIVACY AND BETTER FLOW BETWEEN THE NURSING STATION AND THE NURSERY. MENTAL HEALTH FACILITIES - BROADLAWNS HAS THE LARGEST STAFF OF MENTAL HEALTHCARE PROVIDERS IN CENTRAL IOWA, AND WE ARE TAKING A LEADERSHIP POSITION IN ADDRESSING THE NEEDS FOR EXPANDED ACCESS TO MENTAL HEALTHCARE. TWO YEARS AGO, BROADLAWNS INCREASED ITS INPATIENT BEHAVIORAL HEALTH BEDS FROM 26 BEDS TO 30 BEDS. THE INPATIENT UNIT CONTINUES TO OPERATE AT 100% CAPACITY, 365 DAYS PER YEAR. THE NEEDS FOR EXPANDED ACCESS TO MENTAL HEALTHCARE CONTINUE TO GROW. BROADLAWNS RECENTLY COMPLETED A TRANSFORMATIVE RENOVATION OF THE INPATIENT BEHAVIORAL HEALTH UNIT TO PROVIDE MODERNIZED PATIENT ROOMS, ADDITIONAL TREATMENT AND GROUP THERAPY SPACES, AND ENHANCED AREAS FOR PRIVACY AND VISITORS. THE NEWLY RENOVATED INPATIENT BEHAVIORAL HEALTH UNIT WAS REPOPULATED ON APRIL 2, 2016. BROADLAWNS WILL INITIATE A SECOND PHASE OF CONSTRUCTION THAT WILL EXPAND THE INPATIENT BEHAVIORAL HEALTH UNIT FROM 30 BEDS TO 44 BEDS, WHICH IS THE LICENSED CAPACITY FOR BROADLAWNS. THE ESTIMATED COMPLETION DATE FOR THE INPATIENT EXPANSION IS SUMMER 2017. LAST YEAR, BROADLAWNS OUTPATIENT MENTAL HEALTH CLINIC ACCOMODATED OVER 55,000 VISITS AND WE PROVIDED OVER 15,000 COMMUNITY-BASED VISITS. DEMAND FOR OUTPATIENT MENTAL HEALTHCARE IS CURRENTLY OUTPACING OUR ABILITY TO ATTEND TO THE GROWING NEEDS FOR CARE. IN MARCH 2017, BROADLAWNS WILL OPEN A 72,000 SQUARE FOOT MEDICAL CLINIC BUILDING THAT WILL HOUSE OUTPATIENT MENTAL HEALTH (AND THE FAMILY HEALTH CENTER AND DENTAL CLINIC) AND WILL EXPAND OUR SERVICING CAPACITY FOR OUTPATIENT MENTAL HEALTHCARE BY AT LEAST 40%. WITHIN THE NEW FACILITIES, BROADLAWNS WILL OFFER EXPANDED ADDICTION SERVICES AND INTENSIVE OUTPATIENT THERAPY. DENTAL CLINIC - THE BROADLAWNS DENTAL CLINIC BEGAN WITH A SINGLE OPERATORY CHAIR LOCATED WITHIN THE EMERGENCY DEPARTMENT OVER FORTY YEARS AGO. CURRENTLY, THE DENTAL CLINIC HAS EIGHT OPERATORY CHAIRS AND IS LOCATED WITHIN THE FAMILY HEALTH CENTER BUILDING. IN MARCH 2017, THE DENTAL CLINIC WILL MOVE TO THE NEW MEDICAL CLINIC BUILDING THAT IS PRESENTLY UNDER CONSTRUCTION ON THE EASTERN PORTION OF THE BROADLAWNS CAMPUS. THE BROADLAWNS DENTAL CLINIC WILL EXPAND ITS FOOTPRINT TO INCLUDE 22 OPERATORIES. FOUR OPERATORY SPACES WILL BE DEDICATED TO PROVIDING SPECIALTY SERVICES INCLUDING ORTHODONTICS, ENDODONTICS, ORAL SURGERY, AND PEDIATRICS. THIS TRANSFORMATION WILL DRAMATICALLY INCREASE OUR ABILITY TO ADMINISTER ORAL HEALTHCARE TO THE MOST UNDERSERVED POPULATIONS THAT HAVE HISTORICALLY EXPERIENCED SIGNIFICANT ACCESS BARRIERS TO DENTAL CARE. FAMILY MEDICINE RESIDENCY PROGRAM - THE ONSITE HOUSING APARTMENTS ARE HOME TO THE RESIDENTS FOR THE THREE YEARS PRIOR TO EMBARKING UPON A CAREER IN MEDICINE. THE CURRENT RESIDENCY UNITS ARE OUTDATEAD AND A PLAN IS IN PLACE TO REPLACE THE RESIDENCY HOUSING UNITS WITH TWO NEW RESIDENCY APARTMENT BUILDINGS. CONSTRUCTION ON ONE OF THE TWO PROPOSED HOUSING BUILDINGS IS NEARLY COMPLETE. OTHER PHASES OF MODERNIZATION THAT HAVE BEEN COMPLETED IN RECENT YEARS INCLUDE THE EMERGENCY DEPARTMENT, RADIOLOGY, INPATIENT ROOMS, MEDICAL OFFICE BUILDING, OPERATING ROOMS, SURGICAL AND MENTAL HEALTH WAITING AREAS, MAIN ENTRANCE, FINANCIAL COUNSELING, REGISTRATION, MORGUE.

THE ADVOCATE CIRCLE WAS CREATED TO HELP ADDRESS THE MEDICAL CENTER'S NEEDS FOR ADVOCACY AND FUNDRAISING. IT BRINGS TOGETHER A GROUP OF 16 EMERGING LEADERS (MENTEES) WITH A GROUP OF 9 EXPERIENCED COMMUNITY LEADERS IN BOTH ADVOCACY AND FUNDRAISING (MENTORS). AS A GROUP, THEY WERE CHARGED WITH LEARNING ABOUT THE HEALTH CARE DELIVERY SYSTEM AND THE ROLE BROADLAWNS PLAYS IN THAT SYSTEM. THROUGH TRAINING AND INTERACTION WITH MENTORS, THE MENTEES WERE POSITIONED TO ADVOCATE AND FUNDRAISE USING A COMPREHENSIVE ADVOCACY AND FUNDRAISING PLAN DEVELOPED BY THE GROUP. THE ADVOCATE CIRCLE IS CURRENTLY FOCUSING ON THE "MENTAL HEALTH IN OUR COMMUNITY STARTS WITH ME" CAMPAIGN, AN EFFORT TO RAISE AWARENESS OF THE CURRENT MENTAL HEALTH CARE NEEDS IN CENTRAL IOWA. THE ADVOCATE CIRCLE PLANS TO ADDRESS THESE NEEDS BY RAISING MONEY TO EXPAND AND MODERNIZE THE MENTAL HEALTH CARE FACILITIES OF BROADLAWNS MEDICAL CENTER.
