1. DMH Reimbursed Medication - funds allotted are allocated to non-MOHealthNet eligible clients in our ADA contracted CSTAR program. These costs are deducted from our ADA contract dollars. We consider cost verses benefit analysis in determining the best treatment interventions for the individual client. The Division limits reimbursement to prescriptions of 30 days or shorter lengths of time. The Division doesn't place a limit on the number of times prescriptions may be refilled. We (the provider) identify the clients presenting problem and best practices to address the clients presenting problem through individual treatment. 2. Specific Assistance - funds allotted are allocated to purchase infant supplies such as diapers and formula, medically necessary items such as medication, cab fare to and from medical facilities, GED testing, birth certificate copies and utility bills. Funds are used for open and active clients who show a severe need and have no other resources to meet these needs. 3. Work Experience Program - the goal of this program is to provide work experience for women who are active clients of Lafayette House, who are participating in education job training program and actively seeking employment but who have special barriers to employment. Participants must have completed 8 education sessions to be eligible for placement. Participants must continue to seek independent employment during placement. Participants in the work experience program may receive a stipend for up to 20 hours per week for 12 weeks at Second Chances retail shop
