Day Services - Day Services is provided to individuals with developmental disabilities that are non-ambulatory and at least 18 years old Day Services operates Monday-Friday, 9am-3pm, 225 days per year Day Services participants are involved daily in therapeutic activities that are geared towards achieving individualized goals Such goals include increasing independence, physical capabilities, communication skills, and choice/decision making At the heart of all of these goals (and the heart of the Organization's Day Services) is for participants to develop a sense of self-respect and self-worth

Therapy Services - Pony Bird employs a full time physical therapist to provide physical therapy to the individuals who reside at Pony Bird Other therapists are contracted through the Missouri State Medicaid Waiver program to provide such therapy services as speech therapy and occupational therapy The physical therapist will examine and develop treatment techniques to promote health and restore function Plans are created and parents and caregivers are educated on the individual's current needs
