Promote the arts for their individual, community, and economic benefits 1. Community Resources: ArtsKC provides community resources and connecting opportunities for the arts community. These include roundtable discussions, hosting First Friday events, opportunities to participate at local arts festivals and other arts-related activities. 2. Cultural Portal for the Arts: Work began in fiscal year 2016 to launch a comprehensive cultural event calendar and resource directones that will provide an easier mechanism for arts organizations to promote their respective arts offerings as well as arts patrons to access upcoming events. This portal, in response to one of the needs identified by the Regional Cultural Plan process, is expected to be fully operational in fiscal year 2017. 3. Encounter Events and Apentif Parties: Events that foster support for local arts, events and art collections and serve as a conduit for greater arts appreciation and support.

Support artists and arts agencies with capacity building programs and grants 1. ArtsKC Fund: Grant making program to provide grants and artist awards to arts organizations, arts programs and individual artists. Funds are received through workplace giving campaigns, individuals, businesses, foundations, municipalities and civic organizations. More than \$3.8 million has been granted since its inception in 2007. 2. Mentorship Services for Arts Organizations and Artists: ArtsKC provides one-on-one direct assistance to arts organizations and artists on how to seek grant funding and in making the arts community aware of upcoming arts grant opportunities. 3. Now Showing: More than 60 companies support the Now Showing program where they can select artwork from more than 200 artists for display and sale at their local businesses. This promotes art in non-traditional areas as well as providing opportunities for these artists to display and sell their works. 4. Fiscal Sponsorships: ArtsKC supports the growth of local artistic ventures by serving as a fiscal sponsor for arts organizations or events to expand artistic reach. The fiscal sponsorships have included sponsoring the Brush Creek Art Walk, The National Storytelling Network, the National Council on Education for the Ceramic Arts annual conferences held in Kansas City and fiscal support for the Performing Arts Marketing Group (PAMG). 5. Internship Program: This program provides undergraduate, graduate and recent college graduates the opportunity to learn about the many aspects of working in the arts and not-for-profit sectors. ArtsKC collaborates with local universities and educators to identify top candidates. It then hosts up to 12 interns on an annual basis. 6. Diversity Initiatives: ArtsKC works to build a more inclusive Kansas City through the arts by connecting individuals from all backgrounds with opportunities to serve on not-for-profit boards by providing board member training and by leading dialogues designed to prepare the next generation of diverse arts leaders. ArtsKC has collaborated with the UMKC Midwest Center for Nonprofit Leadership, Central Exchange and other partners in these endeavours.

Advocate for the arts by educating the community, building relationships with government officials, and supporting the development of public funding for the arts. 1. Action Alerts: More than 4,600 people are enrolled in the Action Alerts database. This database allows ArtsKC to inform and engage people around key issues that benefit the arts and the community as a whole, such as public spaces, economic impact of the arts, and safety and cultural opportunities. 2. Annual Awards Luncheon: ArtsKC hosts an annual luncheon in which individuals, arts organizations, schools and elected officials are honoured and recognized for their contributions to the regional arts ecology. More than 1,000 people come together each year to recognize and thank these individuals and organizations for their stellar support for the Arts. 3. Hosting and Sponsoring Advocacy Events: ArtsKC provides meeting space and resources for the hosting of events that raise the awareness of the economic value and quality of life that the Arts provide to the Kansas City region.
