The Oakland Public Education Fund (Ed Fund) supports Oakland public schools by Raising and managing resources for urgent school and district needs, Building partnerships that support innovative teaching and dynamic leadership, Deepening community engagement to connect Oakland to its public schools. Since 2003, the Ed Fund has raised more than \$50 million to support critical initiatives such as after-school programs, family engagement, STEM (Science, Technology, Engineering, and Math), and more. The Ed Fund’s work has led to measurable impact. To cite one example, in its first year the Ed Fund’s Elementary Literacy Collaborative saw 97 percent of students reach proficiency after entering the program reading below grade level, leading OUSD to expand the program District-wide.
