Service Objective Awards - The organization awards grants to community organizations in support of the organization's mission which seeks to improve the lives of women and girls in greater Kansas City Soroptimist Kansas City Foundation has awarded a total of \$1,001,710 in grants from 1954-2016 Virginia Porth was a member of the Soroptimist Kansas City Foundation who worked passionately to increase educational opportunities for women After her death, Soroptimist established an award in her name to assist women in reaching their educational goals In 2008, a named graduate fellowship was established at the University of Missouri - Kansas City to assist a female student in the health field In fiscal year 2015-2016, \$1,660 was awarded to Alexandra's House, \$2,500 was awarded to Mother's Refuge, \$3,500 was awarded to Keeler Women's Center, \$4,848 was awarded to Safehome, and \$5,000 was awarded to four organizations - Kansas City Care Clinic, reStart, Jackson County CASA, and Salvation Army Permanent Supportive Housing

Our Board Members are strong community leaders, with professionals who are lawyers, educators, non-profit employees, and caring community volunteers.
