Jamestown Regional Medical Center is a 25 bed critical access hospital providing short-term acute inpatient, outpatient, swing bed, home health and hospice health care services. The nearest provider of health care services is more than 35 miles away and Jamestown Regional Medical Center is located 100 miles away from the nearest major health service centers in Fargo or Bismarck, North Dakota. Jamestown Regional Medical Center makes medical care accessible to the entire community it serves. In addition to the routine inpatient and outpatient health care services provided, during FYE June 30, 2016 the following were provided: *4,263 inpatient days of which 462 were swing bed and 18 hospice days of care. *39% Medicare is the percentage of inpatient days. *12% Medicaid is the percentage of inpatient days. *8,701 emergency visits of which 723 resulted in inpatient admissions. *32,501 total outpatient visits. *2,308 outpatient surgical procedure visits including outpatient surgery and scopes. *337 live births. *2,051 orthopedic patients. *753 urology patients. *2,124 cardiac rehab visits. *4,355 home health visits. *4,928 hospice days of care. *\$461,538 in free care. *99 volunteers. We provide the following specialty services to the communities we serve: *Urology Treatment of conditions associated with the kidney, bladder and urinary tract. *Wound Clinic. We offer advanced wound care solutions to patients dealing with the issue of wound healing. *Cardiac care and rehabilitation. In addition to emergency and intensive care units our cardiac services include cardiolt stress, adenoscan and adenowalk cardiolt imaging tests and spect imaging tests for accurate diagnosis, and monitored diet and exercise programs throughout the hospital stay and through outpatient care in our cardiac rehabilitation center. *3D Mammography. We have new 3D Mammography technology that detects cancer sooner than ever before. *Emergency care. Our emergency center is staffed 24 hours a day throughout the year and handles everything from broken bones to heart attacks. *Home health services. Services provided to the home bound include nursing, physical, occupational, speech and social services. *Hospice. provide for the physical and psychological needs of the terminally ill and help accommodate their families through a full range of hospice services. *Nutritional counseling. Our registered dietitians provide nutritional assessments and personalized diet plans to optimize health and speed recovery through proper nutrition. *Physical and occupational therapy. Provide a full range of services to help patients recover from on-the-job, sports-related injuries and certain debilitating diseases. *Social services and support groups. Our facility provides a wide range of support in the coordination of services by our social service department and support groups to help our patients and their families cope with the emotional and financial effects of illness. *Podiatry services. Our licensed and credentialed doctor of podiatry medicine treats everything from flat feet to bunions with moderate therapeutic techniques. *Hearing services. We employ a licensed audiologist that can help correct hearing loss. *Surgery center. Our inpatient and outpatient surgery center is capable of handling a wide variety of general and specialized surgical procedures including laparoscopic and cataract procedures. *Other support services -Laboratory, pathology and radiology services. Full range of services to provide accurate diagnosis for treatment -Care line. We operate an emergency response telephone based response center to enable the elderly to remain independent in their homes. *Volunteers and volunteer services. We have, on the average, 99 community volunteers as follows: -Senior companions. Helping senior citizens maintain independence by reading to them, helping with shopping, etc. -Hospice. Assisting hospice patients and families cope with terminal illness. -Children's TLC. Volunteers provide parents with a break with their children that are hospitalized. -Telecare. Maintain contact with your friends or family member through telephone calls to their home. -Gift Shoppe. Operated for the convenience of friends and family of hospital patients to obtain cards, flowers and small gifts for patients in our facility. -Other services. Community members volunteer their services to help out in times of need in most service areas assisting patients and their families.
