University of Mary serves approximately 4,068 students and has 432 faculty members. They have four schools with more than 54 degree programs. In addition, there are 14 graduate degree programs and three doctoral degrees. They average a placement rate of approximately 99 percent overall for their graduates.

Student Aid & Expenses - University of Mary offers various types of financial assistance to students including federal, state, and private programs as well as other forms of student aid and work programs.
