During 2015-2016 we fundraised with the purpose of helping to remodel/update one wing of the nursing home into a "Special Care Unit ." That unit opened in October 2014 and 14 residents with cognitive memory live in the Unit. Heritage Foundation is committed to providing nursing scholarships to help with recruitment and retainment of employees at Hill Top Home of Comfort. This past year, \$10,529 was spent in Nursing Scholarships and Tuition Reimbursement programs. Gifts of equipment to Hill Top Home of Comfort totaled \$227,053.
