Odegard School of Aerospace Sciences. The Foundation's principal activities consist of developing and conducting training programs, research and development, and consulting services related to the aerospace industry. The Foundation's principal activities are located in Grand Forks, ND, with additional flight training centers located in Mesa, AZ, and Crookston, MN. Aviation training - classroom, flight training, and support services delivered to pilot and air traffic control students at Grand Forks campus, with 41,135 flight training hours during the year.
