THE EXPECTED TOTAL RETURN FROM INCOME AND THE APPRECIATION OF INVESTMENTS. 6. OTHER RESOURCES OF THE FOUNDATION. 7. THE INVESTMENT POLICIES OF THE FOUNDATION. THE BOARD OF DIRECTORS DETERMINED THAT THE FOUNDATION SHALL NOT DISTRIBUTE MORE THAN 4% OF ITS ENDOWMENT FUNDS BASED UPON A 3 YEAR (12 QUARTER AVERAGE) OF THE FUND CORPUS AND ITS ACCUMULATED FUNDS AVAILABLE. IF A FUND HAS BEEN IN EXISTENCE FOR FEWER THAN THREE YEARS, THE COMPUTATION SHALL BE CALCULATED BASED UPON THE TIME THAT THE FUND HAS BEEN IN EXISTENCE. IN ESTABLISHING THIS POLICY, THE FOUNDATION CONSIDERED THE LONG-TERM EXPECTED RETURN ON ITS INVESTMENT ASSETS, THE NATURE AND DURATION OF THE INDIVIDUAL ENDOWMENT FUNDS, MANY OF WHICH MUST BE MAINTAINED IN PERPETUITY BECAUSE OF DONOR-RESTRICTIONS, AND THE POSSIBLE EFFECTS OF INFLATION. THE FOUNDATION'S OBJECTIVE IS TO MAINTAIN THE PURCHASING POWER OF THE ENDOWMENT ASSETS AS WELL AS TO PROVIDE ADDITIONAL REAL GROWTH THROUGH NEW GIFTS AND INVESTMENT RETURNS. CURRENTLY, THE BOARD OF DIRECTORS HAS AUTHORIZED THE SPENDING OF ALL INTEREST AND DIVIDEND EARNINGS FROM DONOR RESTRICTED ENDOWMENT FUNDS WHERE NO RESTRICTIONS HAVE BEEN PLACED ON THE EARNINGS FOR DONOR RESTRICTED FUNDS, WITH RESTRICTIONS ON EARNINGS, THE FOUNDATION COMPLIES WITH THE REQUIREMENTS ESTABLISHED BY THE DONOR. ALL EARNINGS FROM DONOR RESTRICTED FUNDS ARE CLASSIFIED AS TEMPORARILY RESTRICTED UNTIL THEY ARE SPENT. BOARD DESIGNATED ENDOWMENT FUNDS ARE CLASSIFIED AS UNRESTRICTED FUNDS. THE BOARD OF DIRECTORS HAS AUTHORIZED THE SPENDING OF ALL INTEREST AND DIVIDEND EARNINGS FOR THE DESIGNATED PURPOSE OF EACH FUND. THESE EARNINGS ARE CLASSIFIED AS UNRESTRICTED EARNINGS. FUNDS WITH DEFICIENCIES FROM TIME TO TIME, THE FAIR VALUE OF ASSETS ASSOCIATED WITH INDIVIDUAL DONOR-RESTRICTED ENDOWMENT FUNDS MAY FALL BELOW THE LEVEL THE DONOR OR SPMIFA REQUIRES THE FOUNDATION TO RETAIN AS A FUND OF PERPETUAL DURATION. IN ACCORDANCE WITH GAAP, DEFICIENCIES OF THIS NATURE THAT ARE REPORTED IN UNRESTRICTED NET ASSETS WERE \$5,636 AS OF JUNE 30, 2016. THIS DEFICIENCY RESULTED FROM UNFAVORABLE MARKET FLUCTUATIONS THAT OCCURRED. RETURN OBJECTIVES AND RISK PARAMETERS: GRAND FORKS FOUNDATION FOR EDUCATION, INC. HAS ADOPTED INVESTMENT AND SPENDING POLICIES FOR ENDOWMENT ASSETS THAT ATTEMPT TO PROVIDE A PREDICTABLE STREAM OF FUNDING TO PROGRAMS SUPPORTED BY ITS ENDOWMENT WHILE SEEKING TO MAINTAIN THE PURCHASING POWER OF THE ENDOWMENT ASSETS. ENDOWMENT ASSETS INCLUDE THOSE ASSETS OF DONOR-RESTRICTED FUNDS THAT THE FOUNDATION MUST HOLD IN PERPETUITY. UNDER THIS POLICY, AS APPROVED BY THE BOARD OF DIRECTORS, THE ENDOWMENT ASSETS ARE INVESTED IN A MANNER THAT IS INTENDED TO PRODUCE RESULTS THAT ALLOW FOR DISTRIBUTIONS OF DIVIDENDS AND INTEREST INCOME WHILE MAINTAINING THE PURCHASING POWER OF THE INVESTMENT PORTFOLIO. ACTUAL RETURNS IN ANY GIVEN YEAR MAY VARY FROM THIS AMOUNT. STRATEGIES EMPLOYED FOR ACHIEVING OBJECTIVES TO SATISFY ITS LONG-TERM RATE-OF-RETURN OBJECTIVES: GRAND FORKS FOUNDATION FOR EDUCATION, INC. RELIES ON A TOTAL RETURN STRATEGY IN WHICH INVESTMENT RETURNS ARE ACHIEVED THROUGH BOTH CAPITAL APPRECIATION (REALIZED AND UNREALIZED) AND CURRENT YIELD (INTEREST AND DIVIDENDS). THE FOUNDATION TARGETS A DIVERSIFIED ASSET ALLOCATION THAT PLACES A GREATER EMPHASIS ON ASSET-BASED INVESTMENTS TO ACHIEVE ITS LONG-TERM RETURN OBJECTIVES WITHIN PRUDENT RISK CONSTRAINTS.
