Upon successful completion of these questions, they receive the application to complete and are provided with a list of supporting documents that must accompany the application. The application and documents are reviewed internally for accuracy and completeness. Complete applications that meet qualification guidelines are reviewed at a monthly committee meeting for final determination of whether direct bill payments will be made (for a 90 day period) on behalf of the applicant and for how much. The amount is based on an overall approved monthly budget for program grants to recipients. The Qualified Recipient Committee is composed of nurses, educators, professionals, and breast cancer survivors. Direct bill payment means that money is sent to the successful applicant's creditors; no money is sent directly to the successful applicant.
