	CSW Networks mission is to serve as a powerful advocate and resource for its memberCommunity Science Workshops, by providing opportunities for youth to tinker, make, and explore their world through science in under served communities across California. The three main programs are grant making, technical assistance and staff development services to its member Community Science Workshops in six sites across California. Altogether CSW Network members serve over 100,000 youth visits and 1000 teacher/educator visits per year. The CSW Network grant making program provides funding to member Community ScienceWorkshop sites. CSW network funds programs that are free to low-income children and families. The CSW network grant making program funds traveling exhibits and supplies to educators who run free programs in the local workshops. The network also purchased computers and equipment for CSW site educators, compiled new activities to the statewide project database, developed a system-wide attendance tracking program, and executed a documentary project to capture alumni success stories over the past 20 years. These efforts contribute to the CSW Network and the local sites capacity to raise more funds to increase open tinkering and Making service hours to children and families who can not afford to go to museums or fee for service science centers. Technical assistance to member Community Science Workshop includes financialmanagement training, executive director coaching, evaluation system training, program management and fundraising training across the state. CSW Network developed community awareness and marketing materials as well as represented the member sites in local, state, and national level meetings with stakeholders and funders. The Technical Assistance program is vital to enhancing the programs and operations of local workshops. The CSW Network designs staff development programs for educators throughout the state and supports training of staff members employed at member Community Science Workshop sites. Training topics include the how to of science conceptual understanding and learning, makerspace pedagogy and best practices to meet new state standards in math and science, key strategies to support English Language Learners, and special exhibit demonstrations for events such as Maker Faire, Family Science, and Science Festivals. In order to maximize the accessibility of these trainings, and therefore their positive impact on programs for youth, the CSW Network provided travel support, stipends for participating staff, and additional resources for use by each site. The CSW Network also makes it possible for educators and member site staff to attend events and conferences relevant to the field of informal science education, where educators gain tools to enhance their local programs.
