Spektral Quartet NFP employs a classical string quartet (two violins, viola and cello) called the Spektral Quartet that serves the organization by promoting the education and expansion of music written for string quartet through performance and educational activities. Spektral Quartet NFP was formed in 2011 and since then has made in excess of 225 public appearances, commissioned more than 70 composers, and has worked with public and private University students around the Midwest and beyond, including the University of Chicago, where it serves as ensemble-in-residence. The large majority of the organization's activities occur within the Chicagoland Area, with some concert tours taking the quartet to Vermont, Maryland, D.C., New York, California, Michigan, Wisconsin, South Carolina, and Georgia. Our organization served an estimated 7,000-8,000 people during FY'16.
