Safe Harbor staff can be contacted via telephone 24 hours a day, 7 days a week, 365 days a year. The Organization shelters victims and children of domestic violence for a temporary period of time while they are looking for a new, safe place to live. The Organization also provides advocacy services for victims of domestic violence, sexual assault, bullying, and stalking. In FY2016, Safe Harbor assisted 1676 women, children and men that were victims of domestic violence. Safe Harbor also assisted 206 stalking victims, 149 sexual abuse victims, 33 adolescent sexual abuse victims, 5 child abuse victims, 96 domestic violence protection orders, and 29 stalking protection orders. The Organization sheltered 69 women and 61 children, providing 2,763 bed nights and 8,289 meals.

Kids Konnection served as a supervised visitation and exchange center for individuals referred by a court system, Department of Social Services, attorneys or others if there are difficulties exchanging children with another caretaker including when a court order restricts contact between parents or emotional safety is compromised. In fiscal year 2016, there were 857 supervised child exchanges and 720 hours of supervised visitation.
