| Sexual Assault and Domestic Violence Services TCC provides crisis intervention, advocacy, and counseling to primary and secondary victims of sexual assault, domestic violence, stalking and human trafficking. In FY16 TCC served 719 victims of sexual assault and 340 victims of domestic violence, 88 of the victims served were children. Crisis intervention includes staff and volunteers responding to the immediate needs of victims. During FY16 TCC provided service to 68 victims in the emergency room and answered 206 crisis calls during after-hours. TCC is the leader of the community Sexual Assault Response Team (SART). Advocacy services may include assistance to victims during hospital exams, law enforcement investigations, obtaining protection orders, and courtroom accompaniment. TCC also helps victims make connections to other needed community resources. Ongoing counseling services are provided to primary and secondary victims. Counseling is continued for as long as the victim wishes. TCC provides emergency financial assistance to victims who need help with transportation, rent, and other necessities. |                                                                                                                |
