FAMILIES ARE SELECTED BASED ON THEIR ABILITY TO AFFORD A MODEST MORTGAGE, THEIR WILLINGNESS TO PARTNER IN THE PROGRAM, AND THEIR INELIGIBILITY FOR OTHER FINANCING. 50-75 PEOPLE VOLUNTEER WEEKLY, WITH AN ESTIMATED 12,000 VOLUNTEER HOURS PER YEAR. LONG-TERM MORTGAGE FINANCING IS THE KEY COMPONENT THAT MAKES BHAHFH HOMES AFFORDABLE. HOMES ARE SOLD TO LOCAL LOW-INCOME FAMILIES, THE MAJORITY OF WHICH EARN LESS THAN 50% OF THE AREA MEDIAN INCOME. MONTHLY MORTGAGE PAYMENTS COLLECTED BY BHAHFH ARE ADDED TO THE DONATION RESOURCES USED FOR BUILDING ADDITIONAL HOMES FOR FAMILIES IN NEED. MORE THAN 300 PEOPLE HAVE BEEN PLACED IN HOME SINCE 1990. BHAHFH PARTNERS WITH CORPORATE PARTNERS, THE CITY OF RAPID CITY, AND THE SD HOUSING DEVELOPMENT AUTHORITY TO ACCOMPLISH ITS MISSION. IN ADDITION, THE "HOME PRESERVATION" (HP) PROGRAM PROVIDES PAINTING, LANDSCAPING, WEATHERIZATION AND CRITICAL REPAIRS TO QUALIFYING LOW-INCOME HOMEOWNERS STRUGGLING TO MAINTAIN THEIR HOMES. HP SERVED 9 LOCAL HOMEOWNERS IN 2016 AND ENGAGED 119 VOLUNTEERS THROUGHOUT THE YEAR.
