The club financed the remainder of the project with a \$355,100 bank loan. The City of Aberdeen has pledged net concession revenue at Storybook Land to repay the club's bank loan. The club also helps maintain and update the park as the need arises. Also, the Sertoma Club received other miscellaneous revenue from storybook land, including a grant for funding the summer storybook land festival.
