THE MISSION OF ADVANCING STUDENTS FORWARD (Part III, line 1)

The organization's primary purpose is to provide marginalized students with scholarships, academic support services and enrichment activities to promote their academic and professional success. The mission of Advancing Students Forward (ASF) is to provide disadvantaged students access to education and support for academic success so that they can provide a promising future for themselves and the community in which they live. ASF serves an average of 75 needy students in grades 7 to the university level. Students must demonstrate economic need, provide evidence of good grades and live in the vicinity of the community center in the town of Tecolote in the city of Tijuana, Mexico. Students are required to participate in monthly meetings, maintain good grades and perform service projects.

SCHOLARSHIPS (Part III, line 4 a)

Each year an average of 75 needy students from various communities in Tijuana, Mexico are given economic assistance. This enables them to access school beyond the 6th grade. In Mexico, 50% of students do not complete their education after 6th grade because they must pay for tuition and books. In many communities the schools cannot accommodate the number of students who want to enroll because of a lack of space. As a result, many students who do continue their studies must enroll in schools in neighboring communities and this compounds the expense incurred by them to continue their schooling. ASF students are required to attend monthly meetings, participate in service projects and maintain good grades. Scholarships are given on a monthly basis to help with the tuition and educational expenses provided the students have fulfilled their monthly requirements and obligations to the program. Work Study opportunities are also available to the students. ASF students staff the community center providing office support and tutoring more than 70 children from the neighborhood. They serve as teachers for the many classes offered to the community, including homework support, English and computer classes. Participants of ASF also prepare the curriculum and staff the month-long summer camp program for more than 100 elementary school children. ASF students are looked upon as role models in the community.

STUDENT SUPPORT (Part III, line 4b)

Students receive educational supplies, mentoring, opportunities for leadership, community building and parent/student workshops. During monthly student meetings students are supported in a variety of ways. This includes team-building and educational presentations and workshops to provide academic support and guidance. University level students serve as team leaders. They are responsible for directing the meetings and for preparing the educational presentations. Alumni of ASF continue to participate and mentor the current students. They also serve as ambassadors for ASF in the broader community. Parent/student workshops are offered 2 times a year to strengthen the child/parent bond. This helps to expand the parent's understanding of the academic challenges and requirements their children face and

improves their communication, strengthening their relationships. Each academic year a specific curriculum is designed to meet the student's needs and to expand their horizons. The 2015-2016 school year curriculum focused on STEAM (science, technology, engineering, art and mathematics). ASF partnered with the Engineering Department of the University of San Diego. Students were taught about the engineering design process and how it can be applied in a collaborative environment to transform simple ideas and materials into complex multi-disciplinary systems. Students put into practice problem solving skills and learned the language and concepts of the engineering design process. Students experimented with electrical circuits, levers and robotics. Students created simple machines and then progressed in complexity to complete their culminating project. Using the Rube Goldberg model of chain reaction machines students completed 2 chain reaction machines consisting of various modules and multiple steps. Exposure to the STEAM curriculum provides students exposure to areas of study they may not have been aware of. It also offers them opportunities to explore, practice and contemplate different career paths. Curriculum presented in past years include: Self-expression through art and mural painting, Internet safety and etiquette, human trafficking, communication between parent and adolescent, public speaking, goal setting, self-respect, sexuality and family values. Curriculum for the 2016-2017 academic year will continue to focus on STEAM with an emphasis on Mathematics and Mathigami (Mathigami is a strategy that combines origami and mathematical concepts to encourage students to seek alternate ways to think and solve problems. Origami reinforces habits that lead to success in mathematics.) The partnership between Advancing Students Forward and the University of San Diego will continue in the upcoming year.

ENRICHMENT (Part III 4c)

Enrichment activities include field trips to expose the students to the many cultural, educational and professional opportunities in Baja California, Mexico. Students also have opportunities to attend conferences outside of Tijuana. Students with visas participate in cross-cultural, binational events and exchanges with students on the U.S.A. side of the border including International Friendship Games in Chula Vista, CA, and the World Link, STEAM and Geek Girl Conferences at the University of San Diego.

Advancing Students Forward provides long-term support and guidance to the students. Each year 10 new students who are entering the seventh grade are accepted into the program. The expectation is that the students will continue to participate in ASF until they have completed their university or technical studies. Most students remain in the program for 6-10 years. ASF boasts 19 university graduates. For the 2016-2017 school year ASF will serve 21 students in the university, 4 in technical courses, 22 in high school and 26 in middle school.
