The Savila Collaborative is dedicated to reducing mental health disparities in New Mexico by making preventative primary mental healthcare services including counseling, psychotherapy, case management and drug and alcohol additional recovery services available to anyone in Bernalillo County and the surrounding community regardless of their ability to pay

The Sivila Collaborative d b a Centro Sivila is a treatment program devoted to the recovery and healing of individuals, families, and communities suffering from emotional and psychological distress. Our vision is a healthy, engaged and equitable community. Our mission is to improve the mental health of our community by ensuring access to linguistically and culturally relevant, quality mental health and prevention services, education and healthcare professional development. Our comprehensive model of care works to decrease health disparities in Bernalillo County by providing outpatient mental health services, systems navigation, no-cost health insurance enrollment assistance for Medicaid and the New Mexico Health Insurance Exchange, school-based counseling, therapeutic gardening, food security support, drug and alcohol counseling and recovery support, and supervision, training and research opportunities for students and health professionals. Our treatment approach is based on the key pr

Clinical The Sivila Collaborative provides preventative primary mental healthcare direct clinical services including outpatient mental health assessment, evaluation, counseling, psychotherapy, medication management and drug and alcohol addiction recovery treatment available to anyone in Bernalillo county and the surrounding community, regardless of their ability to pay. During FY 15-16, The Sivila Collaborative Contracted to provide off-site school-based clinical services at Robert F Kennedy Charter High School and offered free school-based counseling services to Spanish speaking students. Provided healthcare to over 850 unduplicated patients. Hired a new Prescribing Psychologist to provide psychiatric assessment, evaluation, psychotropic medication prescription and medication management to our patients. Implemented mindfulness and stress management skills groups for patients experiencing anxiety and depression. Provided facilitation for the Girasol program that provides one on one and group education and counseling for patients diagnosed with Type II Diabetes and Pre-Diabetes and support for their families. Provided outpatient drug and alcohol counseling to over 50 court-mandated patients. Began collaborative work with Casa de Salud on developing the Raices Fuertes opiate/opioid holistic outpatient treatment program, provided critical incident stress debriefing to participants of partner organizations and expanded services in our therapeutic garden

Outreach and Enrollment During FY 15-16, The Sivila Collaborative worked to expand health insurance coverage in New Mexico by training employees to become enrollers for Presumptive Eligibility Medicaid On Site Application Assistance (PEMOSAA) and the New Mexico Health Insurance Exchange. Centro Sivila hired a team of 4 bilingual outreach and enrollment specialist who scheduled over 1500 appointments and successfully enrolled 850 people in Medicaid and 150 in private health insurance. The enrollment team also participated in outreach efforts to inform the public about health insurance options and eligibility. The Outreach and Enrollment team performed over 1000 hours on outreach and education efforts. The enrollment team attended over 200 events within the Bernalillo area, focusing our outreach and education efforts to target the South Valley communities. We encountered thousands of individuals by distributing marketing materials within the community and school events, local businesses and community centers. Our bicultural/bilingual team was able to reach out to Latino/Hispanic and Spanish speaking New Mexicans who are the largest uninsured population in NM

Healthcare Professional Pipeline The Sivila Collaborative is actively working to decrease the mental healthcare provider shortage in New Mexico by providing community-based training and internship opportunities for students working towards degrees in Social Work, Counseling, Psychology and Psychiatry. During FY 15-16, The Sivila Collaborative Provided free clinical supervision to 3 masters degree student interns, 1 doctoral student conducting practicum placement, and 1 psychiatry resident. All of the supervision was for bilingual students that want to go into health professions. The Sivila Collaborative is a loan repayment site for clinicians that want to work in federally designated health professional shortage areas (HPSA). The South Valley is a health professional shortage area. In addition to free clinical supervision, the Sivila Collaborative provided funding for clinicians to take licensure examination prep courses and for the cost of their licensing examinations. This support helped one of our Spanish-speaking clinicians to obtain independent licensure. All of the members of our health insurance outreach and enrollment team were also given training to become Community Health Workers. During the past fiscal year, The Sivila Collaborative was able to enroll one of our clinicians in the National Health Service Corps which payed off \$25,000 of the clinicians student loans. Clinicians from Centro Sivila provided over 50 hours of school and community information and outreach and school lectures to students interested in or studying mental health related fields. Participated in 5 professional association presentations, and participated in several collaboratives and coalitions aimed at decreasing health disparities in Bernalillo County. During this fiscal year, The Sivila Collaborative applied for and received funding for the Via a la Salud/Pipeline to Health program which is aimed at increasing the number of culturally and linguistically appropriate mental health professionals in New Mexico. Food Security During FY 15-16, The Sivila Collaborative extended the scope of our therapeutic garden project by increasing the number of clients served while partnering with other groups in the South Valley to expand our Food Security program. The Therapeutic Garden project contracted with a local, bilingual farmer to maximize the use of the garden and to educate patients on how to grow healthy and nutritious foods. The garden was also used by the South Valley Young Mens program that provided gardening workshops to over 30 South Valley high school students whose families struggled with food insecurity and taught sustainable farming techniques. The students broke ground on a 200 square foot greenhouse they were constructing to be able to grow crops year round. This year over 20 bags of groceries, and household supplies were distributed weekly to South Valley patients with food insecurity. During this fiscal year The Sivila Collaborative began work on the Community Table project which engages community in facilitated design workshops to create an outdoor table and shade structure where group activities and food distribution will take place upon completion. Research and Advocacy The Sivila Collaborative participates in research examining the social determinants of health, access to behavioral health services, and clinical outcomes. During FY 15-16, The Sivila Collaborative Participated in the Building Movement Research Project that examined collaborations of Non-Profit Organizations in New Mexico. The Executive Director and several employees provided education to policy makers in the State Legislature, Albuquerque City Council and the Bernalillo County Commission about existing gaps in New Mexico's behavioral health and case management services for the poor and the need for expanded funding for behavioral health services and New Mexico's healthcare safety net. As a member of the La Red del Rio Abajo collaborative, the Executive Director spoke at a Resolana community forum that gathered community members and policy members to provide education around gaps in behavioral health services in the South Valley. As a member of the Albuquerque Interfaith Coalition, The Sivila Collaborative hosted a community forum to provide input to the entity contracted by Bernalillo County to put together a comprehensive county plan for behavioral health. Centro Sivila hosted international speakers and put on community events to share international models of community participatory research. The Executive Director also participated with a Sivila Collaborative board member and community health worker in a research and investigation interchange with MEDICC to visit public health sites in the cities of Havana and Matanzas, Cuba to build better understanding of inter-sectoral collaboration, prevention, community engagement and education in public health

Form 990, Part III, Line 4d Other Program Services Description	OTHER PROGRAM SERVICES 4 Healthcare Professional Pipeline The Sviла Collaborative is actively working to decrease the mental healthcare provider shortage in New Mexico by providing community-based training and internship opportunities for students working towards degrees in Social Work, Counseling, Psychology and Psychiatry During FY 15-16, The Sviла Collaborative Provided free clinical supervision to 3 masters degree student interns, 1 doctoral student conducting practicum placement, and 1 psychiatry resident All of the supervision was for bilingual students that want to go into health professions The Sviла Collaborative is a loan repayment site for clinicians that want to work in federally designated health professional shortage areas (HPSA) The South Valley is a health professional shortage area In addition to free clinical supervision, the Sviла Collaborative provided funding for clinicians to take licensure examination prep courses and for the cost of their licensing examinations This support helped one of our Spanish-speaking clinicians to obtain independent licensure All of the members of our health insurance outreach and enrollment team were also given training to become Community Health Workers During the past fiscal year, The Sviла Collaborative was able to enroll one of our clinicians in the National Health Service Corps which payed off \$25,000 of the clinicians student loans Clinicians from Centro Sviла provided over 50 hours of school and community information and outreach and school lectures to students interested in or studying mental health related fields, Participated in 5 professional association presentations, and participated in several collaborates and coalitions aimed at decreasing health disparities in Bernalillo County During this fiscal year, The Sviла Collaborative applied for and received funding for the Via a la Salud/Pipeline to Health program which is aimed at increasing the number of culturally and linguistically appropriate mental health professionals in New Mexico Food Security During FY 15-16, The Sviла Collaborative extended the scope of our therapeutic garden project by increasing the number of clients served while partnering with other groups in the South Valley to expand our Food Security program The Therapeutic Garden project contracted with a local, bilingual farmer to maximize the use of the garden and to educate patients on how to grow healthy and nutritious foods The garden was also used by the South Valley Young Mens program that provided gardening workshops to over 30 South Valley high school students whose families struggled with food insecurity and taught sustainable farming techniques The students broke ground on a 200 square foot greenhouse they were constructing to be able to grow crops year round This year over 20 bags of groceries, and household supplies were distributed weekly to South Valley patients with food insecurity During this fiscal year The Sviла Collaborative began work on the Community Table project which engages community in facilitated design workshops to create an outdoor table and shade structure where group activities and food distribution will take place upon completion Research and Advocacy The Sviла Collaborative participates in research examining the social determinants of health, access to behavioral health services, and clinical outcomes During FY 15-16, The Sviла Collaborative Participated in the Building Movement Research Project that examined collaborations of Non-Profit Organizations in New Mexico, The Executive Director and several employees provided education to policy makers in the State Legislature, Albuquerque City Council and the Bernalillo County Commission about existing gaps in New Mexicos behavioral health and case management services for the poor and the need for expanded funding for behavioral health services and New Mexicos healthcare safety net As a member of the La Red del Rio Abajo collaborative, the Executive Director spoke at a Resolana community forum that gathered community members and policy members to provide education around gaps in behavioral health services in the South Valley As a member of the Albuquerque Interfaith Coalition, The Sviла Collaborative hosted a community forum to provide input to the entity contracted by Bernalillo County to put together a comprehensive county plan for behavioral health Centro Sviла hosted international speakers and put on community events to share international models of community participatory research The Executive Director also participated with a Sviла Collaborative board member and community health worker in a research and investigation interchange with MEDICC to visit public health sites in the cities of Havana and Matanzas, Cuba to build better understanding of inter-sectoral collaboration, prevention, community engagement and education in public health
