Funding Western Washington University to pursue their goal of understanding changes in cellular metabolism, especially in liver cells. Using funds provided by the Hartig foundation they have been able to design experiments using tracer chemicals which enable them to follow the fate of consumed sugars, proteins and fat by liver cells. The analysis is being done in collaboration with the lab of Dan Raftery at the University of Washington. Dr. Raftery is a world leading expert in measuring changes in human metabolism - working with him they have already been able to precisely measure the fate of chemicals as they're consumed by liver cells, setting them up for their large experiments in the spring.
