APE is a fitness & wellness program designed for senior adults of all ability levels who have either (1) been diagnosed with a medical condition like diabetes, hypertension, or arthritis; (2) completed all of the available rehabilitation provided; or (3) are trying to prevent the onset or recurrence of any of the above. By offering an accessible & affordable exercise & ed. venue for an under served segment of the population, APE hopes to continue to reduce healthcare costs by maintaining or improving participants' current level of health.

APE currently offers 12 general conditioning classes, which includes individual personal training. APE also offers 11 specialty classes including - chair yoga, modified Zumba, weight loss, circuit training, Parkinson's, yoga for Parkinson's, and walking.

4b (Code:) (Expenses \$ 2500 including grants of \$ 2500) (Revenue \$ 0)

This year over 500 people attended APE's Annual Active Aging Week in September. The week's presentation included classes; various health lectures on topics as osteoporosis, arthritis and Parkinson's, and screenings including blood pressure. Mini seminars were presented on topics including device and computer use, identity theft and mail scams, pet care assistance.

4c (Code:) (Expenses \$ 1874 including grants of \$ 0) (Revenue \$ 1874)

APE offers a monthly Nutrition and Healthy Eating Presentation, focusing on local fresh seasonal fruits and vegetables. About 180 participants enjoyed local produce and learned the benefits of healthy eating. They learned which produce to buy organic and which produce organic doesn't matter as much. New foods are tried monthly, calendars noting what produce is available in the area and when it is in season are shared. They received calendars noting what produce is available in the area and participants take home some recipes to make themselves.
