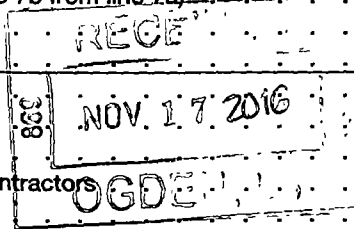

The primary purpose of the organization is to instruct church pastors to communicate the Bible effectively in their own culture. This is carried out in North America as well as internationally.

**Part II Balance Sheets:** In the initial organizational years, the organization has operated on a cash basis and utilized volunteer's equipment, thus, has accumulated no assets to be reflected on a balance sheet. Likewise, there are no liabilities. Thus the balance sheet simply reflects cash on hand.

**Part III Statement of Program Accomplishments:** The primary purpose of the organization is carried out through the conducting of projects throughout the world. A summary of those projects follow:

In 2015-2016, there were six countries in which seven projects each lasting two weeks were carried out. The countries included Cuba, Myanmar, Vietnam, Romania (2 projects), India and Kenya. Over 150 local pastors participated in these projects. All projects including books supplies, venues, etc were financially underwritten by CrossTalk Global. Total expenditure was \$43,000.

In 2015-2016, there were four events in North America involving week-end seminars of instruction at which over 75 participants attended. These events were held in California (2), Massachusetts, and Minnesota. The format while much more condensed was similar to the international projects involving instructions in the principles of effectively communicating the Bible in one's own culture. Total Expenditures were \$6,300.
