	ORTOP has entered into several agreements with a 501(c)(3) nonprofit organization in New Hampshire called For Inspiration and Recognition of Science and Technology (FIRST) to deploy youth robotics in Oregon. FIRST LEGO League Junior, FIRST LEGO League and FIRST Tech Challenge. FIRST creates annual robotic competitions in several age groups and provides information for coaches, youth participants, volunteers, etc. to help provide local, regional, national, and international contests with a common set of rules. FIRST depends on affiliate partners to run the contests in many parts of the USA. A501(c)(3) nonprofit organization in Washington, called Washington FIRST Robotics (WA FIRST), has entered into similar agreements with FIRST to deploy these programs in Washington. WA FIRST has entered into an additional agreement with FIRST that provides that WA FIRST deploy FIRST Robotics Competitions (FRC - a robotics competition for high school students) in Washington and Oregon including hosting several other youth robotics events in Oregon. ORTOP did not have responsibility for FRC in Oregon during the fiscal year described in this return. Accordingly when ORTOP received donations, which the donor designated to be used in support of FRC FIRST Robotics Competitions and supporting events, the amount of these donations designated for FRC were allocated to WA FIRST. The total of these allocations was \$315,000. See Schedule I for additional details.
