AASLD FOUNDATION INVESTS IN INNOVATIVE HEPATOLOGY RESEARCH AND IN THE PEOPLE WHO STUDY AND TREAT LIVER DISEASE THROUGH ITS RESEARCH AND CAREER DEVELOPMENT AWARDS PROGRAM. THE AASLD FOUNDATION PROVIDES GRANTS TO INSTITUTIONS TO SUPPORT THE RESEARCH WORK OF YOUNG INVESTIGATORS AND THE SPECIALIZED EDUCATION OF FELLOWS, TRAINEES, AND OTHER FRONT-LINE PROVIDERS. AASLD FOUNDATION'S CLINICAL TRAINING AWARDS ARE ONE-YEAR AWARDS MADE TO FOURTH-YEAR HEPATOLOGY FELLOWS ENROLLED IN AN ACCREDITED ADULT OR PEDIATRIC TRANSPLANT HEPATOLOGY PROGRAM OR TO NURSE PRACTITIONERS/PHYSICIANS ASSISTANTS SEEKING ADVANCED TRAINING IN LIVER DISEASE. THESE AWARDS PROVIDE SALARY AND BENEFIT SUPPORT TO PROTECT Awardees' TIME WHILE THEY PURSUE ADVANCED CLINICAL TRAINING IN HEPATOLOGY. AASLD FOUNDATION RESEARCH AWARDS ARE MADE TO YOUNG INVESTIGATORS PURSUING LIVER-RELATED RESEARCH, AND RANGE FROM ONE YEAR, \$20,000 TO THREE YEARS, \$300,000. FUNDS CAN BE USED ONLY FOR THE Awardee's SALARY SUPPORT OR RESEARCH SUPPORT/SUPPLIES RELATED TO THE FUNDED PROJECT. NO INDIRECT COSTS ARE ALLOWED. THE AASLD FOUNDATION ALSO PROVIDES TRAVEL AWARDS TO YOUNG INVESTIGATORS WHO SUBMIT PROMISING RESEARCH TO BE PRESENTED AT THE LIVER MEETING. THESE AWARDS ENCOURAGE THE EXCHANGE OF INNOVATIVE IDEAS IN HEPATOLOGY, AND HELP DEVELOP YOUNG INVESTIGATORS BY ALLOWING THEM TO BE ABLE TO PRESENT THEIR WORK TO AN INTERNATIONAL AUDIENCE. AASLD FOUNDATION CLOSELY MONITORS AWARD RECIPIENTS THROUGH INTERIM PROGRESS AND FISCAL REPORTS FROM THE RECIPIENT AND INSTITUTION REGARDING SCIENTIFIC PROGRESS AND USE OF FUNDS. THE RECEIPT OF EACH SUBSEQUENT YEAR OF FUNDING IS CONTINGENT ON THE REVIEW AND APPROVAL OF INTERIM REPORTS BY THE RESEARCH AWARDS COMMITTEE. FINAL PROGRESS AND FISCAL REPORTS ARE REQUIRED AT THE END OF THE AWARD PERIOD.
