DURING THIS FISCAL YEAR, THE RHODE ISLAND CENTER FOR JUSTICE CONTINUED AND EXPANDED ITS PROVISION OF FREE LEGAL ASSISTANCE TO LOW-INCOME RHODE ISLANDERS IN AREAS OF CRITICAL NEED. IN OUR THREE MAIN AREAS OF LEGAL PRACTICE - HOUSING, EMPLOYMENT AND UTILITIES ACCESS, CENTER FOR JUSTICE STAFF DIRECTLY ASSISTED HUNDREDS OF HOUSEHOLDS THROUGH A RANGE OF LEGAL SERVICES INCLUDING BRIEF ADVICE AND COUNSEL, PRE-LITIGATION ADVOCACY, AND REPRESENTATION IN ADMINISTRATIVE AND COURT PROCEEDINGS. THROUGH THE SUCCESSFUL OPERATION OF THESE PROGRAMS, THE CENTER FOR JUSTICE OBTAINED SIGNIFICANT RELIEF FOR ITS CLIENTS SUCH AS DESPERATELY NEEDED REPAIRS OF RENTAL HOUSING CONDITIONS, RENT ABATEMENTS, RECOVERY OF EARNED BUT UNPAID WAGES, AND PREVENTION OF GAS AND ELECTRIC UTILITY SHUT OFFS. BEYOND INDIVIDUAL CASE WORK, THE CENTER FOR JUSTICE FILED A CLASS ACTION LAWSUIT AGAINST A LARGE PUBLIC UTILITY AND THE STATE OF RHODE ISLAND ON BEHALF OF LOW-INCOME, MEDICALLY VULNERABLE UTILITY CONSUMERS FOR SYSTEMIC VIOLATIONS OF REGULATIONS, CONSTITUTIONAL DUE PROCESS AND ANTI-DISCRIMINATION STATUTES. IN FURTHERANCE OF OUR MISSION, THE CENTER FOR JUSTICE ALSO CONDUCTED A FIRST OF ITS KIND, SEVEN WEEK INTENSIVE SKILLS TRAINING SERIES FOR NEW LAWYERS WHICH FOCUSED ON LEGAL REPRESENTATION OF LOW-WAGE, IMMIGRANT WORKERS IN CIVIL ACTIONS TO ADDRESS WAGE THEFT. IN PARTNERSHIP WITH ROGER WILLIAMS UNIVERSITY SCHOOL OF LAW, THE CENTER FOR JUSTICE ENGAGED IN SUBSTANTIAL TRAINING OF LAW STUDENTS THROUGH EXTERNSHIPS AND OTHER EDUCATIONAL PROGRAMS.


