The program was aired on an average of 900 terrestrial radio outlets across the U.S. The program is also available via a podcast, a smart phone app, and on-line.  International MinistriesBack to the Bible International communicates the Word of God in ways that are clear, culturally appropriate and readily understood.  Youth OutreachgoTandem is a smartphone app or web-based experience that sends registered users personalized biblical content up to 12 times throughout the day, based on the user's choice. Using this complex algorithm, goTandem knows users well enough to curate and individualize biblical content that meets their deepest spiritual struggles.
