Funds continued to be received in 2015 for construction of a new open-sided metal beef barn. The following amounts were received in this fiscal year: \$1000 each from the Bertrand Vet Clinic and Pioneer Seed Company. The Phelps County Community Foundation also held a one-day give2Grow activity that brought in donations of \$3,605 for kitchen improvements, including the purchase of two wall ovens for the Ag Center in Holdrege.
